**ORDER**

**WHEREAS** the appeal of Sree Dattha Brindavan Institute of Teacher Education, Kavarampally Sivar, Singaram X Road, Narayanpet, Mahabubnagar, Telangana dated 16/05/2018 is against the Order No. - F.SRC/NCTE/SRCAPP14884/B.A.B.Ed./B.Sc. B.Ed./TS/2017-18/96899 dated 06/03/2018 of the Southern Regional Committee, withdrawing recognition, for B.Sc. B.Ed. on the grounds that (i) This is a case for B.Sc. B.Ed. (2 Units). (ii) We had given FR for B.Sc. B.Ed. (2 units) w.e.f. 2018-19 on 6.2.18. (iii) But, this decision was reviewed on 24.2.18 and rescinded pending verification of fulfilment of the requirement for the Faculty to have Ph.D. degree and/or NET qualification. (iv) Their reply to our SCN in this regard is examined. (v) The Faculty list is checked once again. The Faculty list is of 1+15 as prescribed; they satisfy the other requirement of qualifications. (vi) The following members do not have Ph.D. degree or NET qualification and therefore are not eligible. Sh. V. Sreenivasulu, Sh. D. Suresh, Sh. P. Venkata Subbiah, Sh. K. Rajashaker, Sh. K. Ashok Kumar, Sh. A. Mallaiya, Sh. M. Venkateswarulu & Shri C.S. Anjaneyalu. (vii) The Faculty list is also deficient on counts of not carrying the photographs of 5 Asst. Profs and of not being authenticated in every page by the Registrar. (viii) That being so, we can not modify our order dt. 24/02/2018. Withdrawal of the recognition granted earlier was correct and is hereby confirmed. (ix) Inform accordingly the applicant and the affiliating University.

**AND WHEREAS** Sree Dattha Brindavan Institute of Teacher Education, Kavarampally Sivar, Singaram X Road, Narayanpet, Mahabubnagar, Telangana was asked to present the case of the appellant institution on 31/07/2018 and 04/10/2018 but nobody from the institution appeared. The Committee decided to give the appellant a final opportunity to present their case.


**AND WHEREAS** Sh. M. Rangareddy, Correspondent, Sree Dattha Brindavan Institute of Teacher Education, Kavarampally Sivar, Singaram X Road, Narayanpet, Mahabubnagar, Telangana appeared before Appeal Committee on 18/02/2019 and submitted that a list of faculty was furnished to S.R.C. on 11/03/2018 after noting the minutes of 357<sup>th</sup> Meeting of S.R.C. held on 23-24 February, 2018. The list of faculty submitted by appellant institution, in response to the S.C.N. dated 02/03/2018 was found to be deficient on account of not carrying the photographs of 5 Assistant Professors and few of the faculty were found to be not having Ph.D. or NET.

**AND WHEREAS** the institution approached the Hon'ble High Court Hyderabad for the State of Telangana in W.P. No. 3725/2019 and the Hon'ble Court disposed of the matter vide its order dated 01/03/2019 directing to dispose of the appeal within a week.

**AND WHEREAS** Appeal Committee noted that appellant during the course of appeal hearing on 18/02/2019 was able to show evidence of having required number of faculty having Ph.D./NET qualification. The list of faculty had all the photographs and was authenticated by Registrar, Palamuru University, Mehboobnagar on all the pages. Considering that (i) the requirement of Ph.D./NET qualification was introduced by NCTE in June, 2017 and the appellant institution was issued L.O.I. prior to this date and (ii) of late the appellant institution has been able to comply with the requirements, Appeal Committee decided to remand back the case to S.R.C. for revisiting the matter. Appellant institution is required to submit the revised list containing the photographs of all faculty members and their qualifications to S.R.C. within 15 days of the issue of Appeal Order.

**AND WHEREAS** after perusal of the Memoranda of Appeal, affidavit, documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to remand back the case to S.R.C. for revisiting the matter. Appellant institution is required to submit the revised list containing the photographs of all faculty members and their qualifications to S.R.C. within 15 days of the issue of Appeal Order.

**NOW THEREFORE, the Council hereby remands back the case of Sree Dattha Brindavan Institute of Teacher Education, Kavarampally Sivar, Singaram X Road, Narayanpet, Mahabubnagar, Telangana to the SRC, NCTE, for necessary action as indicated above.**
