

The Committee decided that Visiting Team be constituted to verify the infrastructural and instructional facilities available with the institution. The VT shall also verify the facilities for existing recognized teacher education courses and ascertain the fulfillment and maintenance of regulations and norms and standards for the existing courses as well being run by the same Society.
