The only deficiency pointed out by us in this case on 24.2.18 was about lack of NET qualification for the faculty members.</li> <li>2.1. The College has represented that it was just not possible for them rectify this deficiency in 7 days i.e, before 3.3.18.</li> <li>2.2. They have, therefore, requested for issue of a conditional FR.</li> <li>3. Admittedly, the time available is not adequate. But, the SRC can not help it. As pointed out in no.3. of our summary decision on 24. Feb 18, we ourselves came to know of this amendment only on that date.</li> <li>4. Unfortunately, the SRC has no power to issue conditional FRs. We can not, therefore, accept the College's request for such a facility.</li> <li>5. The College's representation is not acceptable. Inform them accordingly</li> </ol>

The University has categorically stated and certified that all the 10 Faculty Members of the M.Ed (1 unit) programme fulfil the requirement of having Ph.D. degree or the NET qualification.</p> <p>2.2. The Faculty list submitted by them with the Registrar's authentication confirms this position.</p> <p>3.1. Their reply to our SCN is satisfactory.</p> <p>3.2. There is, therefore, no need to review the decision of 6.2.18 to issue FR for M.Ed (1 unit) w.e.f. 2018-19.</p> <p>3.3. Issue the FR.</p>

For M.Ed a faculty strength of 1 (Principal) + 2 (profs) + 2 Associate Profs + 6 (Asst profs) are needed. They have given a list of only 1 (prof.) + 1 (Associate Prof) + 4 (Asst Profs).</p> <p>3.2. In other words, as against a requirement of 1+ 10 they have indicated only 0+6.</p> <p>3.3. The list also is not authenticated by the Registrar.</p> <p>4.1. The following deficiencies are noticed ;</p> <p>(i) The post of Principal is vacant.</p> <p>(ii) Out of the two Profs one is qualified .</p>

					<p>The other post is vacant.</p> <p>(iii) Out of the two Associate Profs only one is in place ; he is qualified. The other post is vacant.</p> <p>(iv). Out of the six posts of Asst Profs only four are in position all of them are qualified. Two posts are vacant.</p> <p>4.2. To sum up, as against a requirement of 1+2+2+6 they have only 0+1+1+4.</p> <p>5.1. We can not take any decision on the basis of such a defective Faculty list.</p> <p>5.2. Issue Notice accordingly.</p>

The Communication from our lawyer is seen.</p> <p>2.1.The proposed Writ Challenges the validity of the NCTE (amended) Regulation prescribing NET as an essential qualification for recruitment of a teacher.</p> <p>2.2.We have only abided by the amended Regulation.</p> <p>3.1. It is of greater concern to NCTE (HQ). They may have to sustain the validity of the amendment.</p> <p>3.2. Therefore, either they should become a party to the proceedings or provide all the inputs to us for incorporation in our counter.</p> <p>3.3. Inform the NCTE (HQ) of these developments and seek advise.</p> <p>4. Advise the lawyer of all the relevant details</p>

					<p>so as to enable him to prepare drafting the counter.</p> <p>5. In our opinion, it is the domain -regulator's prescription that will preponderate. We must defend this case strongly.</p>

There are many deficiencies ;</p> <p>(i) For M.Ed (1 unit) we need 11 Faculty Members (1+2+2+6). They have given a list of 1+ 10.</p> <p>(ii) Service Certificate of principal is not given. He is otherwise qualified.</p> <p>(iii) The list is approved and authenticated in every page by the Registrar.</p> <p>(iv) Two profs are appointed. Both are qualified.</p> <p>(v) Two Associate Profs are appointed. Their M.Ed qualification is shown as 'second class'. But, we need to know the percentage of marks scored.</p> <p>(vi) Six Asst Profs have been appointed. Only one (Dr. B.Bakkiyaraj) is fully qualified. The other five Mrs. Leoni Mary, Mrs. Marian Rani, Mrs. Santhi, Mrs.Chitra and Mrs. Rajalakshmi-do not have Ph.D or NET qualification. Mrs. Rajalakshmi's M.Ed is shown as second class ; but, we need to know the percentage marks scored.</p> <p>3. Issue SCN for rejection.</p>

They have rectified the deficiencies relating to number of Asst. Profs and to affixing of photograph of one Asst. Prof.</li><li>3.1. But, the objection about the 6 Asst Profs not having NET qualification or Ph.D degree has not been satisfactorily settled.</li><li>3.2. This requirement has been prescribed as essential qualification by the NCTE through an amendment to the 2014 Regulations notified in the official Gazette on 9.6.17.</li><li>3.3. The SRC has no power to relax this qualification. The SRC also has no power to issue a conditional FR allowing recruitment of NET qualified faculty subsequently.</li><li>4.1. In the result, and for the reasons given above, their request for a conditional FR is rejected.</li><li>4.2. But, they are given time till 31.12.2018 to rectify these deficiencies to that they can at least be considered for the 2019-20 academic year.</li></ol>
