- 3. NOW, THEREFORE in exercise of the powers vested under Section 140 (a) of the NCTE Act, 1993, the Eastern Regional Committee hereby to the recognition to Krishnanagar B.Ed. College, 56, Ramsey Road, Chasapara, P.O.- Krishnanagar, Dist Nadia, West Bengal-741101 for conducting B.Ed. Course of one year auration with an annual intake of 100 (one hundred) students with effect from issue of this order. The institution shall ensure that fulfillment of the following:
 - a) The institution will ensure that the teaching faculty members (1(one) Principal +7 (seven) teachers) duly qualified as per NCTE norms, are in position for an intake of 100 students before the commencement of the course and a report to this effect shall be sent to the Eastern Regional Continittee before the commencement of the course and information be put up in the institution website as per 6.6.75 regulation 2005 notified in Gazette of India dated 13th January 2006.

- b) The institution shall pay salary to the teaching staff as prescribed by UGC/University through Account Payee Cheque.
- c) The number of administrative staff shall be maintained as per NCAL norms. The qualifications of technical support staffs shall be maintained as per norms prescribed by concerned affiliating University / UGC. The qualifications of the administrative staff shall be maintained as per norms prescribed by concerned State Govt/affiliating University.
- d) The institution shall, within one month of the receipt of recognition order, convert the Endowment Fund account into a joint account to be operated along with an official of the Eastern Regional Committee.
- e) The institution shall obtain affiliation from the examining body before the commencement of the course.
- f) The institution shall maintain and update their website as per NCTE regulations.
- g) Apart from the qualifications prescribed for teachers for B.Ed. Course, the candidate shall have to qualify NET/SET qualifications or alternative qualifications thereto as prescribed by UGC from time to time before the commencement of the academic session 2009 2010.
- h) The intake, eligibility and admission procedure shall be strictly adhered as per NCTE norms.
- i) Performance Appraisal Report shall be submitted by the end of every academic year on the prescribed format.

- j) The institution shall adhere to all the other regulations are guidelines as framed by NCTE from time to time.
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc, wherever applicable.
- 5. The institution shall submit to the Eastern Regional Committee a Sulf Appraisal Report at the end of each academic year along the statement of annual accounts duty audited by a Charted Accountant.
- 6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued faces under, the Eastern Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
