WITHDRAWAL ORDER**

WHEREAS, recognition was granted to the institution namely J.V.R.R. Memorial College of Education, Lakshmikanta Reddy Estate, Railway Station Road, Nandyal-518502, Andhra Pradesh run by J.V.R.R. Educational Society, Lakshmikanta Reddy Estate, Railway Station Road, Nandyal-518502, Andhra Pradesh vide SRC (NCTE) order no. F.AP/B.Ed/Ext/44/SRO/NCTE/2000-2001/1595 dt. 16.08.2000 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2000-2001.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 09.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, a Revised Provisional Recognition Order was issued to the institution on 26.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 considered the matter and decided that Show Cause Notice be issued to all such institutions which have not submitted compliance of conditions stipulated in RPRO.

AND WHEREAS, as per the decision of SRC a show cause notice was issued to the institution on 06.03.2019. The institution vide letter dated 22.03.2019 submitted reply to the show cause notice.

AND WHEREAS, the SRC in its 376<sup>th</sup> meeting held on 11<sup>th</sup> – 12<sup>th</sup> June, 2019 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-


The Committee decided to withdraw the recognition granted to J.V.R.R. Memorial College of Education, Lakshmikanta Reddy Estate, Railway Station Road, Nandyal 518502, Andhra Pradesh for conducting B.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the following grounds: -

1. Latest faculty list duly approved by the competent authority not submitted
2. The details in the EC and the location of the college is not matching.

3. The land document is not clearly registered in the name of society rather it is a gift deed.
4. No exclusive building is shown for Teacher Education.
5. Land Conversion Certificate is not in favor of institution rather is in the individual name.

**NOW, THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **J.V.R.R. Memorial College of Education, Lakshmikanta Reddy Estate, Railway Station Road, Nandyal-518502, Andhra Pradesh** run by **J.V.R.R. Educational Society, Lakshmikanta Reddy Estate, Railway Station Road, Nandyal-518502, Andhra Pradesh** for conducting **B.Ed** programme of two years duration with an annual intake of 100 students (2 units) on the grounds mentioned above.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
