WHEREAS, recognition was granted to the institution namely Bapuji College of Education, No. 16/7/30,31 Sheraff Bazar, Tenali, Guntur District-522403, Andhra Pradesh run by Kamala Educational Society, Guntur District, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/APSO7958/B.Ed/2007-2008/13131 dt. 18.10.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

**AND WHEREAS,** on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 29.01.2015 for its willingness for adherence of provisions of new Regulations.

**AND WHEREAS,** a Revised Provisional Recognition Order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

**AND WHREAS,** on the basis of request, the SRC in its 342<sup>nd</sup> meeting decided for reduction of intake from 2 units to 1 unit. Accordingly, a order No. F.No.SRO/NCTE/APSO7958/B.Ed/AP/2017-18/94301 dated 09.08.2017 was issued reducing intake from 2 units to 1 unit.

**AND WHEREAS**, the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 considered the matter and decided that Show Cause Notice be issued to all such institutions which have not submitted compliance of conditions stipulated in RPRO.

AND WHEREAS, as per the decision of SRC a show cause notice was issued to the institution on 18.02.2019. The institution vide letter dated 13.03.2019 submitted reply to the show cause notice.

**AND WHEREAS,** the SRC in its 377<sup>th</sup> meeting held on 03<sup>rd</sup> & 04<sup>th</sup> July, 2019 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

(i) The institution failed to submit requisite documents as per SCN dated 18.02.2019.

The Committee decided to withdraw the recognition granted to Bapuji College of Education, No 16/7/30, 31 Sheraff Bazar, Tenali Guntur District – 522403,
