SHOW CAUSE NOTICE U/S 17

WHEREAS, recognition was granted to the institution namely Aadi Lakshmi College of Education, Survey No. 120/2, Navakhandayada, Pithapuram, East Godavari District-533450, Andhra Pradeshrun by BavisettiKondala Rao Educational Society, East Godavari SRC (NCTE) Andhra Pradesh vide District-533450. F.SRO/NCTE/B.Ed./APSO9536/2008/5564 dt. 01.10.2005 for conducting B.Ed. course of oneyear duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 13.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, a Revised Provisional Recognition Order was issued to the institution on 20.03.2015 for conducting B.Ed. course of two years duration with an annual intake of100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, the SRC in its 368th meeting held on 08th - 09th January, 2019 considered the matter and decided as under:

- 1. The college was issued an RPRO on 23.03.15 subject to fulfilment of certain conditions.
- 2. They have not complied with most of the conditions. They have only submitted Photocopies of some FDRs.
- 3. This gross recalcitrance is not acceptable.
- 4. Issue a SCN for withdrawal of recognition.
- 5. Put up in the 370th meeting.

AND WHEREAS, as per the decision of SRC a Show Cause Notice issued to the institution on 18.01.2019. The institution vide letter dated 29.01.2019 submitted reply to the show cause notice. The SRC in its 373rd meeting held on 26th - 27thMarch, 2019 considered the matter and decided as under:

The original files of the Institution alongwith other related documents, NCTE Act, 1993. Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC.

The Committee noted that the institution has requested for enhancement of intake from one unit to two units and decided that the request of the institution will not be considered.

Further for approval of continuance of the existing programme with one unit, the following observations were made:-

- The institution is required to submit certified copy of land documents. (If the same are in Regional Language the institution is also required to submit notarised copy of English version of land documents)
- Land Use Certificate issued by the Competent Authority.
- Non Encumbrance Certificate issued by the Competent Authority.
- A copy of the approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognised Teacher Education programme)
- Building Completion Certificate as per prescribed Format.
- Staff list duly approved by the affiliating body as per the prescribed Format.

Hence the Committee decided to issue SCN on the above points.

AND WHEREAS,as per the decision of SRC a Show Cause Notice issued to the institution on 08.04.2019. The institution vide letter dated 15.04.2019 submitted reply to the show cause notice. The SRC in its 376th meeting held on 11th – 12thJune, 2019 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee decided to issue Show Cause Notice u/s 17 of NCTE Act, 1993 for B.Ed course before withdrawal of the recognition on the following grounds:-

- 1. The institution is required to submit certified copy of land documents. (If the same are in Regional Language the institution is also required to submit notarised copy of English version of land documents)
- 2. Land Use Certificate issued by the Competent Authority.
- 3. Non Encumbrance Certificate issued by the Competent Authority.
- 4. A copy of the approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognised Teacher Education programme)
- 5. Details of Teacher Education programme/other programme (if any) being run by the institution in the same campus

6. Building Completion Certificate as per prescribed Format.

7.Staff list duly approved by the affiliating body as per the prescribed Format.

8.Original FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years.

In view of above the institution is required to submit representation/compliance accompanied with an affidavit from the authorized representative of the Management. The representation along with an affidavit must reach this office <u>within 21 days</u> of the issue of this letter/notice. In case, the office does not receive any representation within stipulated time, it will be presumed that the institution does not wish to make any representation, and the Southern Regional Committee shall take decision as per provisions of the NCTE Act, Rules and Regulations.
