The minutes of the 297th Meeting were confirmed by the Committee.


Agenda 298.2: Action Taken Report of 297th Meeting of WRC.

(ODL)	<p>After perusal of directions of Appellate Authority dated 05.06.2018 vis-à-vis NCTE Act & Regulations, 2014 as well as reply dated 06.06.2018 received at WRC vide email dated 13.09.2018, the Committee observed that:-</p> <p>(i) Vide Refusal order of WRC dated 24.01.2018, it was clearly mentioned that the institution had to submit letters of approval from UGC/DEB.</p> <p>(ii) However, vide letter dated 06.06.2018 received by email on 13.09.2018, the institution has submitted a copy of letter of UGC having direction to MAT not to admit any students instead of copy of approval letter of UGC/DEB, as sought by the WRC vide its decision taken in the meeting dated 286th meeting.</p> <p>Hence, the decision of the Committee taken in its 286th meeting stand confirmed in view of the facts mentioned above.</p>

D.Ed.- 150 seats 2. B.Ed.- 100 seats 3. M.Ed.- 50 seats Total - 300 seats</p> <p>(b) Recognised Courses 1. B.Ed. M.Ed. (Integrated) -50 seats</p> <p>(c) Refused courses 1. M.Ed. (Addl.) -50 seats 2. B.Sc. B.Ed. 3. B.A. B.Ed.</p> <p>As per NCTE Regulations, 2014, vis-à-vis norms prescribed for the respective courses, the institution is required to have atleast 6,000 sq.mtrs. of built-up area for running as well as proposed M.Ed. (Addl.) course. However, as per documents submitted by the institution vide letter dated 21.07.2018, the required built-up area is less than the prescribed norms for M.Ed (Addl.) course.</p> <p>Hence, the Committee decided to communicate the institution the decision of the WRC that Refusal Order dated 25.04.2017 stand confirmed in view of the facts mentioned above.</p>
